Dear Prime Minister Harper,

British Columbia's ports are the heart of Asia Pacific trade for our nation and for our province.

Small businesses have a large stake in the free flow of goods through our ports. British Columbia's small businesses shipped about \$12.2 billion worth of merchandise to international destinations in 2006. That represents close to 37% of the total value of goods exported from the province.

Small business plays a major role in British Columbia's economy. British Columbia's small business GDP accounted for a third of total provincial GDP - the highest of all provinces. More than 56% of B.C.'s private-sector jobs are in small businesses.

That's why I am writing to you today – to express our concerns about the reliability of the Asia Pacific Gateway due to perpetual labour disputes at our ports. Once again a protracted labour negotiation is underway between the British Columbia Maritime Employers Association (BCMEA) and the International Longshoremen Workers Union (ILWU) Foremen - Local 514, which represents less than 10 per cent of the longshore labour force.

But all those investments, all the trade, and all our overseas customer relations, are at risk of being choked by the labour situation.

We are calling on the Government of Canada to ensure the security and reliability of the Asia Pacific Gateway. The time for action is now. In this tough economic time, we need reliability if we are to be successful. Our ports, just like our businesses, faces significant competition and we need to make sure we are seen as being reliable and effective.
